Opening Agenda

1. Call Meeting to order.

The Special Meeting of the City of Ingleside was called to order by Mayor Adame at 6:30 p.m. on September 20, 2022, at City Hall 2671 San Angelo Ingleside, TX and live video streaming.

2. Roll Call.

With Council Members present a quorum was established.

3. Invocation.

Council Member Pruitt led the invocation.

4. Pledge of Allegiance.

Mayor Adame led the Pledge of Allegiance to the U.S. flag.

5. Citizen Comments and Reports

At this time, written comments received by 4:00 p.m. on the day of the meeting, on any subject matter that is not on the agenda, will be read and summarized in the minutes of the meeting. Persons wishing to address the Council and who have registered using the Citizen Participation Form will have up to three minutes to speak. In accordance with the Open Meetings Act, Council may not discuss or take action on any item that has not been posted on the agenda. While civil public criticism is not prohibited; disorderly conduct or disturbance of the peace as prohibited by law shall be cause for the chair to terminate the offender's time to speak.

6. Deliberate and take appropriate action of second and final reading of an Ordinance providing for the levy of taxes for the year 2022 on all real and personal property within the corporate limits of the City of Ingleside, Texas; and appropriating monies for the payment of expenditures for the maintenance and upkeep of the City of Ingleside, and for other purposes.

City Manager Lewis addressed the council to present the final reading of the proposed ordinance for the levy of taxes. The proposed debt levy is now at .116634 and the proposed maintenance and operation tax levy remains the same at \$.422913, for a total of \$.539547, a decrease of \$.08182/\$100 valuation.

Motion: Mayor Adame made the motion to approve Ordinance 2022-18, an Ordinance providing for the levy of taxes for the year 2022 on all real and personal property within the corporate limits of the City of Ingleside, Texas; and appropriating monies for the payment of expenditures for the maintenance and upkeep of the City of Ingleside, and for other purposes. Council Member Pruitt seconded the motion. Motion carried with all present voting in favor.
